

NOVEMBER 2024 ELECTION DEADLINES & DETAILS

You may **register** to vote **in Connecticut** if you meet the following criteria:

- You are a U.S. citizen and a resident of a CT Town who will be 18 by Election Day.
- You meet the criteria above and have completed confinement and parole if previously convicted of a felony.

Voter Registration Deadlines: Online, By Mail and In Person: October 18

Can't register online? Register in person at Town Hall or download a registration form at <https://voterregistration.ct.gov/OLVR/welcome.do> and drop it off or mail it to Town Hall, 400 Main St, Ridgefield, CT 06877. Registrars of Voters questions: 203-431-2771 or 2772



Same Day Registration: Missed the Oct. 18 deadline? Register and vote during the Early Voting period times (see below) or on Election Day at **Ridgefield Town Hall**, 400 Main Street, 6 am – 8 pm. Bring a current ID, proof of current residential address and be prepared to wait in line!

Early Voting: October 21-31 & November 1-3 at Town Hall, 10 am-6pm Extended hours 10/29 and 31 8am-8pm

Polls are Open: 6 am – 8pm on 11/5. **Polling Locations:** District 1: East Ridge Middle School; District 2: Scotts Ridge Middle School; District 3: Yanity Gym; District 4: East Ridge Middle School.

Absentee Ballot Applications: You must fill out an absentee ballot **application** to get an absentee ballot either by going on line (if you have a CT Driver's license) to the CT Online Absentee Ballot Request Portal at: <https://oabr-sots.ct.gov/OABR/absenteeBallotReqPortalHome.do> or by requesting an application for an absentee ballot from the Town Clerk or downloading an application at myvote.ct.gov/absentee and return it to the Town Clerk at 400 Main St.

“CT law allows you to receive an absentee ballot if, in your judgment, an absence from your town on Election Day prevents you from appearing at your polling place, or you are prevented from appearing at your assigned polling place on Election Day because of sickness or physical disability (not necessarily your sickness or disability), active service in the Military, religious tenets forbid secular activity on the day of the election, duties as an election official at a polling place other than your own during all of the hours of voting”. **The vote to amend the CT constitution to allow “No Excuse” Absentee Balloting will be on the 11/5/24 ballot.**

Absentee Ballots become available on October 4 and will be mailed to those who have sent in an application. Ballots may be placed in the Ballot Drop Box which is located to the right of the Main Street front door of Town Hall, dropped off at Town Hall in person, or mailed back using the USPS. To check online to see if your absentee ballot has been received by the Town Clerk, go to <https://portaldir.ct.gov/sots/LookUp.aspx> Absentee Ballots will be available to fill out and submit in person at Town Hall beginning October 4. As required, an Absentee Ballot Application must be filled out first.
